

It is critical that India continues its strong growth trajectory to keep driving an otherwise sluggish global economy. As the world's largest democracy and with a highly diverse society, India's regional and global engagement has more than a symbolic significance. India's role is crucial if this is to be Asia's century.

From low-cost electrocardiograph machines to a successful – yet frugal – Mars mission, Indian entrepreneurs are demonstrating their mettle through innovation across sectors and fields. At the same time, Indian cinema, yoga and Ayurveda bear testimony to the diverse impact of Indian narratives on the world. India now needs to increase its leadership in global projects – a trend that is already underway. The country's leadership in the Paris Agreement and International Solar Alliance, and efforts to become a permanent member of the UN Security Council and the Nuclear Suppliers Group demonstrate a quest for a renewed international identity and a changing perception of its role in international development.

However, for this to be realized, India must ensure its economic, social and political foundations are truly robust and resilient. And it must develop innovations with more global relevance. The biometrics-based identification system Aadhar is one such example.
